Instructions for Foreign Nationals/Persons of Indian Origin (PIOs)/ Non-Residential Indians (NRIs)admitted to B.Tech. Programs though DASA 2024

Foreign Nationals/ Persons of Indian Origin (*PIOs*)/ Non-Residential Indians (*NRIs*) offered admission to B. Tech. Programs through DASA in Rounds 1 to 4 have to report to IIITD offline on 5th August 2024. The induction program will be started from 6th August 2024 and the same shall also be posted on the website. Further, classes will commence from 12th August 2024 in offline mode.

For offline reporting, candidates have to submit the below documents along with requisite fee as follows:

1. List of Documents to be submitted (Originals must be available with the candidates for verification):

- (i) Print out of Admission Letter issued by DASA.

- (iv) For Indian Nationals, Proof of completion of 11th and 12th Standard or equivalent from outside India (*Certificate from school authorities in the format given Appendix II & IV of DASA 2024 UG Admission Brochure*).
- (v) Copy of the candidate's Passport (*Nationals of Nepal who do not have a passport, copy of Authenticated Citizenship Card has to be submitted*).
- (vi) Candidate Visa (*If applicable*)
- (vii) JEE Score Card
- (viii) IIITD Joining Documents (See Annexures)
