

Office Order No. 129/2025

**Subject: Scholarship Schemes of IIIT-Delhi**

In supersession to the Office Order No. 220/2025, dated 13 February 2025, the Board of Governors, in its 71<sup>ST</sup> meeting, has approved the following recommendations of the Scholarship Committee. The Scholarship schemes listed below will be implemented from the AY 2025-26.

**1. Chairman's Scholarship Schemes:**

To recognize and support academic excellence, the following scholarships will be awarded to incoming students based on their JEE Main ranks:

- (a) Students securing a JEE Main rank within the top 1000 will be awarded a scholarship covering 100% of the tuition fees.
- (b) Students securing a JEE Main rank between 1000-2000 will be awarded a scholarship covering 50% of the tuition fees.

**Additional conditions**

Subject to the following conditions:

- The student must not be receiving any other scholarship.
- If the student is eligible for any Government or private scholarship, they must apply for it. If the student becomes the recipient of other scholarships with a total amount less than the tuition fee, the Institute's scholarship will be adjusted accordingly by deducting the amount of the external scholarships, ensuring that the total scholarship amount does not exceed the tuition fee.

Students awarded scholarships under the Chairman's Scholarship in the first year will remain eligible to receive the scholarship for the subsequent years (up to a maximum of 8 active semesters), provided they meet the following conditions:

- (a) Maintain a minimum CGPA of 7.5 at the end of the previous academic year.
- (b) No more than one "F" grade across two semesters in the previous academic year.
- (c) Must not be found guilty of any academic dishonesty or disciplinary violations during the entire program.
- (d) The scholarship will be applicable only for the first 8 active semesters. Students requiring additional semesters beyond the standard four-year duration will not be eligible for the scholarship during the extended period.
- (e) The scholarship will not be applicable during any approved semester leave; however, the leave period will not count toward the 8 active semesters.
- (f) If the student is eligible for any Government or private scholarship, they must apply for it. If the student becomes the recipient of other scholarships with a total amount less than the tuition fee, the Institute's scholarship will be adjusted accordingly by deducting the amount of the external scholarships, ensuring that the total scholarship amount does not exceed the tuition fee.

**2. Women Empowerment Scholarship in STEAM Education (WESSE) Scheme:**

The top 100 female students who have secured an aggregate of more than 95% marks in their class XII Board Examination and have taken admission in any B.Tech. program at IIIT-Delhi will be awarded a scholarship equivalent to 50% of the tuition fee, subject to the following conditions:

- The candidate must not be receiving any other scholarship.
- If the candidate is eligible for any Government or private scholarship, she must apply for the same. If the student becomes the recipient of other scholarships, with a total amount less than the tuition fee, the Institute's scholarship will be adjusted accordingly by deducting the amount of the external scholarships, ensuring that the total scholarship amount does not exceed the tuition fee.

Students awarded scholarships under the WESSE Scholarship in the first year will remain eligible to receive the scholarship for the subsequent years (up to a maximum of 8 active semesters), provided they meet the following conditions:

1. Maintain a minimum CGPA of 7.5 at the end of the previous academic year.
2. No more than one "F" grade across two semesters in the previous academic year.
3. Must not be found guilty of any academic dishonesty or disciplinary violations during the entire program.
4. The scholarship will be applicable only for the first 8 active semesters. Students requiring additional semesters beyond the standard four-year duration will not be eligible for the scholarship during the extended period.
5. The scholarship will not be applicable during any approved semester leave; however, the leave period will not count toward the 8 active semesters.

#### **Additional conditions**

6. If the candidate is eligible for any Government or private scholarship, she must apply for the same. If the student becomes the recipient of other scholarships with a total amount less than the tuition fee, the Institute's scholarship will be adjusted accordingly by deducting the amount of the external scholarships, ensuring that the total scholarship amount does not exceed the tuition fee.

### **3. IIIT-Delhi Merit cum Means (MCM) Scholarship:**

Under this scheme, students across all four years (1<sup>st</sup> to 4<sup>th</sup> year) of the B.Tech. program will be eligible for a 100% tuition fee waiver, subject to the condition that the student must be a beneficiary under the National Food Security Scheme (NFSS) and/or belong to the Below Poverty Line (BPL) category, with a valid card issued under the respective scheme.

The application process and timeline will be as follows:

1. Fresh applications will be invited each year. Every year, a student has to apply afresh.
2. The applications will be submitted after the fee payment deadline for both the Monsoon and Winter Semesters.
3. The process will be closed within the financial year.
4. The details and documents submitted by the student will be verified, and the scholarship will be awarded after due approval of the Competent Authority.

Students awarded scholarship under the MCM Scholarship in the first year will remain eligible to receive the scholarship for the subsequent years (up to a maximum of 8 active semesters), provided they meet the following conditions:

- Satisfy the eligibility criteria at the time of application.
- Maintain a minimum CGPA of 7.0 at the end of the previous academic year.
- No more than one "F" grade across the two semesters in the previous academic year.
- Must not be found guilty of any academic dishonesty or disciplinary violations during the program.
- The scholarship will be applicable only for the first 8 active semesters. Students requiring additional semesters beyond the standard four-year duration will not be eligible for the scholarship during the extended period.
- The scholarship will not be applicable during any approved semester leave; however, the leave period will not count toward the 8 active semesters.

#### **Additional conditions**

- If the student is eligible for any Government or private scholarship, they must apply for the same. If the student becomes the recipient of other scholarships with a total amount less than the tuition fee, the Institute's scholarship will be adjusted accordingly by deducting the amount of the external scholarships, ensuring that the total scholarship amount does not exceed the tuition fee.

**Note: There are no academic performance requirements for students to avail the scholarship in their first year.**

Students applying for any of the three scholarships must submit an Affidavit-cum-Undertaking declaring the following, to be executed on a non-judicial stamp paper of ₹100, duly attested by an Executive Magistrate or Notary Public:

**1. Declaration of Other Scholarships**

The student affirms that for the current academic year, they have not received any scholarship from any private or government source at the time of application.

**2. Obligation to inform the Institute**

If the student receives a scholarship from any other source, they will immediately inform the Institute.

**3. Adjustment Clause**

If the student becomes the recipient of other scholarships with a total amount less than the tuition fee, the Institute's scholarship will be adjusted accordingly by deducting the amount of the external scholarships, ensuring that the total scholarship amount does not exceed the tuition fee.
