NOTICE INVITING QUOTATION (NIQ-07/2022)

Sealed item rate quotations are invited in **two envelope** system for the following work on behalf of the Registrar IIIT Delhi from Eligible Contractors for **Supply of Fire Signage Board at different sizes at IIIT-Delhi**, so as to reach the office of the undersigned upto 3PM on 13th July 2022 in envelope to be opened on the same day at 3:50 PM, in the office of the CE, A-203 2nd Floor of old Academic Block, IIIT-D Campus, Okhla Phase-III New Delhi-110020 in presence of the intending bidders who so wish to attend.

1. The works shall be carried out as per the relevant CPWD / BIS Standards and Terms and conditions, Specifications, BOQ and areas/locations as directed complete.
2. **Time Allowed:** 15 days from issue of Purchase order.
3. Schedule of quantity: As per enclosed BOQ.
4. Clause 12 of GCC CPWD is applicable for EI/SI.
5. Contractor must possess valid GST, PAN, and TIN no.
6. Eligibility Criteria: The agencies must have satisfactory supply/executed **Signage works** in Govt. Deptts/PSU/Reputed Pvt sector /MNCs three works each of value Rs 0.69 Lac or two works each of Rs 0.51 Lac or one work of Rs 0.35 Lac during last 7 years. The applications not supported with requisite experience certificates/work order shall not be entertained. This will be enclosed in **Envelope- I**
7. The financial bid of the tenderers, whose technical bid is found to be suitable, will be opened in the presence of the tenderers, who desire to attend the opening of financial bid.
8. The priced bill of quantities, all duly signed by the authorized signatory of the firms. This will be enclosed in **Envelope- II**.
9. Payment shall be made as per actual quantities of executed works against RA/Final bill at all locations as directed.
10. No advance payment will be made by IIITD. Full and final payment will be released by IIITD only after successful completion of work.



11. Conditional offers will not be accepted. The offer shall remain valid for 60 days. The rates shall remain firm for a period of one year from date of award. The work order may be extended to cover additional areas at same rates as per institute requirements. No variation in rates shall be applicable.
12. Rates to quoted are inclusive of all taxes, duties, cartage, loading and unloading.
13. Contractor will take due permission for entry of all his workers in IIITD. No unauthorized person will be allowed to work inside.
14. All standard protocols such as wearing masks, using sanitizer, maintaining safe distancing norms must be followed by the Contractor and his workers to prevent spread of coronavirus failing which expulsion/ penalty shall be levied on the agency.
15. The workers shall be scanned for temperature before entry as per norms and actions per policy taken.
16. All workers are supposed to use identified utilities of the Institute only.
17. IIIT-D reserves the right to accept or reject any tender in part or whole without assigning any reasons thereof.
