IIIT, Delhi is interested for the supply installation testing and commissioning of Drinking Water Coolers at IIITD Campus Okhla New Delhi as per details below:

- 1. The Water coolers are required to be installed in the of Hostel Block of the IIITD Campus.
- 2. The Water coolers should be heavy duty type with energy efficiency rating as mentioned above and BOQ suitable for 24 hours operation.
- 3. The bidder will be required to ensure trouble free operations of the Water coolers systems at the rated performance with minimum break down during warranty period of one year.
- 4. In addition to break down maintenance the bidder will be required to provide two complete services in a year.
- 5. In case of compressor failure no repairs of compressor shall be allowed. The bidder has to provide replacement of compressor from the company. The compressors shall be guaranteed for replacement for 5 years free of cost.
- 6. The works shall be carried out as per the relevant CPWD / BIS Standards and attached Terms and conditions, Specifications, BOQ and drawing complete.
- 7. **Time Allowed**: 30 days from issue of work order.
- 8. Schedule of quantity: As per enclosed BOQ.
- 9. Clause 12 of GCC CPWD is applicable for EI/SI.
- 10. Contractor must visit site before quoting and fully satisfy himself of the site conditions.
- 11. Contractor must possess valid GST registration no.
- 12. No T&P shall be issued to the Contractor .The contractor shall be provided with electricity and water at one point ,he shall make his own arrangements for further distribution of electricity , water supply and all other labour, tools, plant and equipment etc as required for the works complete. Any damage done to existing walls /ceiling /floors /electrical /fire alarm/ fighting/plumbing equipment /building during execution shall be on the part of the Contractor.
- 13. The requisite certificates along with the EMD be enclosed in Envelope-A. The applications not supported with requisite experience certificates, valid DVAT certificate, TIN no shall not be entertained.
- 14. The priced bill of quantities kept in Envelope-B, all duly signed by the authorized signatory of the firms.
- 15. Payment shall be made as per actual quantities of executed works against RA/Final bills.
- 16. Conditional offers will not be accepted.
- 17. IIIT-D reserves the right to accept or reject any tender in part or whole without assigning any reasons thereof.

MINIMUM ELIGIBILITY CRITERIA

- 1. The bidder should be an authorized dealer of any of the companies whose product is being quoted for.
- 2. The bidder should have a minimum turnover of Rs.10 Lacs from similar works during the last three audited financial years. In this regard the bidder should submit a CA certified copy of turnover in last three financial years.
- 3. The bidder should have a full-fledged service center in Delhi NCR region.
- 4. The bidders should be registered with IIITD /Reputed agencies who have carried out similar works in Govt Deptts/PSU/Reputed Pvt sector /MNCs are to submit the experience certificates for the works and registration certificates with Govt. Depts. if any.
- 5. The agency must have executed 3 similar works of 1.4 lacs OR 2similar works of 2.05 lacs OR 1 similar work of 2.75 lacs. Similar works are defined as works of Supply installation testing and commissioning of drinking water coolers during last seven years. Self attested copies of experience certificates issued by the owners or their GM or Executive Engineer of the department concerned to be submitted.
- 6. The agency should not have suffered any loss in the last two consecutive financial years. This should be certified by the supplier.

BID EVALUATION CRITERIA

- 1. After opening, the bids shall be examined whether the EMD is in order and the bidder meets the minimum eligibility criteria specified above.

- 1. Bid shall be valid for a period of not less than 90 days from the date of opening of bid (envelope number one). Bids submitted without EMD shall be rejected.
- 2. Bids will be opened in the presence of bidders representatives, who choose to attend on the specified date and time.
- 3. Sealed bid can be sent either by post or by messenger.
- 4. Bidder should specify his capabilities & facilities for sales, repairing and maintenance of ACs.
- 5. Bidders will be responsible for covering all risk under Workmen Compensation Act for his employees /machinery on site for installation jobs. IIIT, Delhi will not be responsible for any damages whatsoever on this account.
- 6. In case repairs are not possible on site and required to be repaired outside our premises, all expenditure on this account would be borne by the bidder.
- 7. Payment will be made within one month time on successful installation, issue of satisfactory report by Officer in Charge of IIIT, Delhi and no advance payment will be made
- 8. In the event of dispute, Director, IIIT, Delhi shall be the sole arbitrator and his decision shall be final and binding on both the parties.
- 9. The successful bidder shall be required to submit 5% of total amount of invoice as Performance Bank Guarantee (PG) within 10 days of Order, as security which will be released on expiry of the warranty period. In case, the PG is not submitted the amount of 5% shall be deducted from the bill and released only after warranty period.
- 10. IIIT, Delhi does not bind itself to accept the lowest or any other offer and reserves the right to accept or reject any or all the offers either in full or in part without assigning any reason.
- 11. The Institute is free to charge the quantities for which the bid is called and the payment will be made for actual quantity installed.
