Sealed item rate quotations are invited in two envelop system for the following work on behalf of the Registrar IIIT Delhi from OEM/OEM authorized agencies only for **Repair and maintenance work for the audio and video systems in the Lecture Hall Complex and Lecture Hall at IIIT-Delhi Campus** at IIITD Campus, so as to reach the office of the undersigned up to 11.00 AM on **21**<sup>st</sup> **June 2023** to be opened on the same day at 11.45 AM, in the office of the CE, A-203 2nd Floor of Academic Block, IIIT-D Campus, Okhla Phase-III New Delhi-110020 in presence of the intending bidders who so wish to attend.

**Earnest Money Deposit:** Rs.9,000/- (Rupees Nine Thousand only) is to be submitted with tender document as earnest money. The above payment shall be made in the shape of deposit at pay order/demand draft of a scheduled bank issued in favour of "**IIIT Delhi Collections**" Account payable at New Delhi. (except for those who are exempted by NSIC (certifications must be attached for said works as proof) failing which tender shall be treated as invalid and shall be liable for rejection.

## **GENERAL TERMS AND CONDITIONS: -**

- 1. The works shall be carried out as per the relevant CPWD / BIS Standards and Terms and conditions, Specifications, BOQ and areas/locations as directed complete.
- 2. Any damage done to the equipment/building during execution of work shall be on the part of contractor.
- 3. No T&P shall be issued to the contractor.
- 4. Clause 12 of GCC CPWD is applicable for EI/SI.
- 5. Time allowed 7 days.
- 6. Schedule of quantity : As per Annexure- 'A'
- 7. Contractor must visit site before quoting and fully satisfy himself of the site conditions.
- 8. Eligibility Criteria: The agencies must have satisfactory executed similar works in Govt Deptts./PSU/Reputed Pvt sector /MNCs a three works each of value of Rs 1.80 Lac or two works each of value Rs 2.70 Lac or one work of value Rs 3.60 Lac during last 5 years to submit the work orders/experience certificates for the works and registration certificates with Govt. Depts. if any. The applications not supported with requisite work order/experience certificates shall not be entertained.
- **9.** Only original equipment manufacturer/their authorized dealer/ the System Integrator of OEM are eligible to bid and provide unconditional support for execution/repairing of contract. Tender specific Authorizations from OEM needs to be attached along with bid submission. Without OEM certificate bid will be rejected/disqualified.
- 10. The items shall be covered under defect liability for a period of six months from the date of completion.
- 11. For any equipment to be taken out of the campus for inspection /checking/service an alternate similar service unit is to be provided to enable uninterrupted running of the academic sessions as and when required/called for.



- 12. Conditional offers will not be accepted. The offer shall remain valid for 30 days. The rates shall remain firm for a period of one year from date of award. The work order may be extended to cover additional areas at same rates as per institute requirements. No variation in rates shall be applicable.
- 13. Contractor should depute a qualified supervisor dedicated for this work, who will monitor and coordinate work from contractor's side and interact with the IIITD Engineers, responsible for supervision of work, on regular basis.
- 14. Rates to quoted are inclusive of all taxes, duties, cartage, loading unloading and shifting to location as called for
- 15. Contractor will take due permission for entry of all his workers in IIITD. No unauthorized person will be allowed to work inside.
- 16. All standard protocols such as wearing masks, using sanitizer, maintaining safe distancing normsmust be followed by the Contractor and his workers to prevent spread of coronavirus failing which expulsion/ penalty shall be levied on the agency.
- 17. The workers shall be scanned for temperature before entry as per norms and actions per policy taken.
