The tender fee is exempted for MSMEs/NSIC registered suppliers.
- 2. The last date for submission of Bid is 25th August, 2023 up to 3:00 PM. The Technical Bids shall be opened on the same day, i.e., on 25th August, 2023 at 3.30 PM. The Tender Document should be addressed to:

- 1. The document should be deposited in the Tender Box kept in the Store & Purchase department in Room no. A 107 First Floor, Old Academic Block of the Institute. Bids received after 3:00 PM will not be accepted or considered under any circumstances.
- 2. Bids are invited in Two Bids System, i.e. (1) Technical and (2) Financial.
- 3. An amount of ₹ 40,000/- (₹Forty Thousand only) towards earnest money (EMD) must be deposited in the form of demand draft in favor of "IIIT-Delhi Collections" account, payable at New Delhi. No interest will be paid on the earnest money deposited by the bidder. Tender Document without earnest money will be summarily rejected. EMD is exempted for MSMEs/NSIC registered suppliers.

Introduction-

Indraprastha Institute of Information Technology, Delhi (IIIT-Delhi) was created as a State University by an Act of Delhi Government (The IIIT Delhi Act, 2007) empowering it to do research and development and grant degrees.

Since then, it has come a long way, specializing in diverse areas of Computer Science, Electronics, Mathematics, Computational Biology & Communications Engineering; it has earned a good reputation in India and abroad for being a center of quality education and research in IT and allied areas. At present, the total strength is around 3000 students including all programs.

1. Scope of work-

IIITD invites Tender/ Expression of Interest (EOI) for providing counselling services for emotional wellness of our students for approximate 3000 students for a period of one year, which may be extended further period of two years on year-to-year basis, on a mutual consent, based on satisfactory performance. Interested Health Solution Consultants/ Psycho-therapy Counsellors may submit their offer/quotation in a sealed envelope superscribing as **"Quotation for Well Being Support for Students of IIITD**" containing two separate envelopes, one marked as "Technical Bid" and other as "Financial Bid" in the prescribed format attached as Annexure I and II. Each page of bid document should be properly filled, duly signed and sealed.

2. General Terms and Conditions:

- 01. All rules laid down in the General Financial Rules 2017 and the Manual of Procurement 2017issued by the Department of Expenditure, Ministry of Finance, Government of India will be applicable to this tender.
- 02. The tenderer should submit all required documents asked for in the Technical Bid format, failing which the Tender will be rejected.
- 03.The rates quoted should be indicated in figures as well as in words and there should not be any overwriting as far as possible. Overwriting, if any, should be initialed and office seal affixed.
- 04. Each and every page of the tender documents should be signed by the Tenderer andbe submitted with the Technical Bid as a token of acceptance of terms and conditions of thistender. Technical Bid and Financial Bid should be put in separate sealed covers and both thecovers should be put in a big cover, super scribing "Tender for Well Being Support". Corrections, if any, should be duly signed with seal.
- 05. The quantities specified are only indicative and for the purpose of estimate only. The instituteshall be at liberty to vary (delete/reduce/increase) the quantum of the item. Also, the Institutehas the full right to order or not to order the item to the successful Tenderer.

- 06. The rates quoted (In Indian Rupees) for each item should be inclusive of all cost of material, labor charges, supply and installation of ant equipment, machine etc. at IIITD. No concession forms will be issued for any tax rebate. However, GST/Taxes as applicable at the time of billing will be paid in addition to the quoted price
- 07. The Registrar, IIITD reserves the right to accept or reject any or all the offers in full or part or to waive off any formality, minor deviations and omissions without assigning any reason(s) or to cancel the tender in whole. The Institute reserves the right to reject conditionalTenders and also relax any conditions of Tender at its discretion.
- 08. Submission of offers shall be treated as the acceptance of Terms and Conditions of Tender and any counter terms shall not be accepted.
- 09. Tenderer shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fails to observe and comply with the stipulations made herein orbacks out after quoting the rates, or does not supply the aforesaid items within the stipulated period.
- 10. The rates quoted by the bidder shall remain firm till the completion of the job and price variationshall not be entertained.
- 11. **EMD of ₹. 40,000 need** to be submitted while submitting the Tender. However, an undertaking in the prescribed format (given in Annexure III) as per Rule 170 (iii) of General Financial Rules 2017 isto be submitted.
- 12. **Breach of Terms and Conditions**: In case of breach of any of terms and conditions mentioned above, the Registrar, IIITD will have the right to cancel the work order without assigning and reason thereof, and reserves the right to procure the items mentioned in the purchase order from alternate sources and their extra cost incurred thereof, if any, shall be recovered from the successful bidder and nothing will be payable by this Institute in that event and the security deposit in the form of performance Bank Guarantee shall be uncashed.
- 13. The firm shall not assign or sublet the work or any part of it to any other person or party. That is the tender is not transferable.
- 14. No payment shall be made in advance nor any loan from any bank or financial institutionrecommended on the basis of the order of award of work.
- 15. In case of non-compliance of the work order after entering into Agreement or withdrawal of the offer after submitting tender, the EMD/Security Deposit will be forfeited and the party willbe black listed for 3 years. Also, further action shall be taken at the costs of the Party.
- 16. The Institute is not in any way bound to accept the lowest or any quotation and reserves the right to accept any quotation in whole or any part of the quotation or portion of the quantity offered and reserves the right if required to negotiate with any or all the Tenderers without assigning any reason(s), whatsoever.

- 17. The Tenderer should have its own establishment, which can be inspected by IIITD, before finalization of the Tender.
- 18. The Institute has the right to retain the rates of L-1 to L-X parties as deemed fit.
- 19. If the last date of receipt and opening of the Tender happens to be a declared holiday by unforeseen circumstances, the Tender will be received and opened on the immediate next working day.
- 20. A self-declaration, declaring the bidder has not been blacklisted by a Central/State/Local Government Organization/Academic Institution/PSU to be submitted.
- 21. IIITD requires that the bidders who wish to bid for this work have highest standards of ethics.
- 22. In case of any ambiguity/dispute in the interpretation of any of the clauses in this tender document, interpretation/decision of the Registrar, IIITD shall be final and binding on all parties.

Canvassing, Fraud and Corrupt practices

Bidders are hereby informed that canvassing in any form for influencing the process of notification of award would result in disqualification of the Bidder. Further, they shall observe the highest standard of ethics and will not indulge in any corrupt, fraudulent, coercive, undesirable or restrictive practices, as the case may be. "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of the public official. "Fraudulent practice" means a misrepresentation of facts in order to influence Tender process or an execution of a contract to the detriment of the scheme and includes collusive practice among bidding Insurers/Authorized Representative (prior to or after bid submission) designed to establish bid prices at artificially non-competitive levels and to deprive the scheme the benefit of free and open competition; IIIT-D will reject a proposal for award if it determines that the Insurer/Insurers have engaged in corrupt or fraudulent practices.
