- 6. Contractor must possess valid GST, PAN, and TIN no.
- 7. No T&P shall be issued to the Contractor. The contractor shall be provided with electricity and water at one point, he shall make his own arrangements for further distribution of electricity, water supply and all other labor, tools, plant and equipment etc as required for the works complete. Any damage done to existing walls /ceiling /floors
  - /electrical /fire alarm/ fighting/plumbing equipment /building during execution shall be on the part of the Contractor.
- **8.** Eligibility Criteria: The agencies must have satisfactory executed **Fire door works** in Govt Deptts/PSU/Reputed Pvt sector /MNCs three works each of value Rs 0.84 Lac or two works each of Rs 1.26 Lac or one work of Rs 1.68 Lac during last 7 years. 11. Payment shall be made as per actual quantities of executed works against RA/Final bill at all locations as directed

- 12. Security Deposit / Retention money shall be Two and Half percent (2.5%) of the value of executed works and will be deducted from each and every payment made to the contractor against running account bill submitted for the work done at site. retention money will be released with Employer until the Defects Liability period is successfully over.
- 13. Defect Liability period 12 months from date of completion.
- 14. Protection and maintenance of existing services & Provision for all safety measures for traffic, pedestrian workmen, machinery etc. as considered necessary by the Engineer-in-charge.
- 15. Conditional offers will not be accepted. The offer shall remain valid for 60 days. The rates shall remain firm for a period of one year from date of award. The work order may be extended to cover additional areas at same rates as per institute requirements. No variation in rates shall be applicable.
- 16. Rates to quoted are inclusive of all taxes, duties, cartage, loading unloading and shifting to location as called for
- 17. Contractor should depute a qualified supervisor dedicated for this work, who will monitor and coordinate work from contractor's side and interact with the IIITD Engineers, responsible for supervision of work, on regular basis.
- 18. Contractor will take due permission for entry of all his workers in IIITD. No unauthorized person will be allowed to work inside.
- 19. During execution of work, Engineer may make minor changes in the scope of work as per site conditions or other reasons. Contractor will have no extra claim in his rates for the same.
- 20. All standard protocols such as wearing masks, using sanitizer, maintaining safe distancing norms must be followed by the Contractor and his workers to prevent spread of coronavirus failing which expulsion/penalty shall be levied on the agency.
- 21. The workers shall be scanned for temperature before entry as per norms and actions per policy taken.
