Sealed item rate quotations are invited in two envelope system for the following work on behalf of the Registrar IIIT Delhi from Eligible Contractors for **CCTV works in the Lab No- 318 and 319 on the 3rd floor of Lecture Hall Complex** at IIITD Campus, so as to reach the office of the undersigned up to 3.00 PM on 19th Nov 2024 to be opened on the same day at 3.30 PM, in the office of the PE & EO, A-203 2nd Floor of Academic Block, IIIT-D Campus, Okhla Phase-III New Delhi-110020 in presence of the intending bidders who so wish to attend.

Estimate Cost – 1.45 Lacs

Earnest Money Deposit: Rs 2900/- (Rupees Two Thousand Nine Hundred only) is to be submitted with document as earnest money in favour of “IIIT Delhi Collections”.

Note : MSME and NSIC firms are exempted from EMD. Such firms have to submit documentary evidence in support of their firm’s MSME status in the particular area of operations along with an application for exemption. This will be enclosed in **Envelope- I**.

1. The works shall be carried out as per the relevant CPWD / BIS Standards and Terms and conditions, Specifications, BOQ and areas/locations as directed complete.
2. Any damage done to the equipment/building during execution of work shall be on the part of contractor.
3. No T&P shall be issued to the contractor.
4. Clause 12 of GCC CPWD is applicable for EI/SI.
5. Time allowed 30 days.
6. Schedule of quantity: **As per Annexure- ‘A’**
7. **Contractor must visit site before quoting and fully satisfy himself of the site conditions.**
8. Eligibility Criteria: The agencies must have satisfactorily executed CCTV works in Govt Deptts /PSU/Reputed Pvt sector /MNCs a three works each of value of Rs 0.58 Lac or two works each of value 0.87 Lac or one work of value 1.16 Lac during last 5 years to submit the work orders/experience certificates for the works and registration certificates with Govt. Depts. if any. The applications not supported with requisite work order/experience certificates shall not be entertained.
9. Payment Terms: 30% on supply; 70% on installation, Testing & commissioning.
10. The priced bill of quantities, all duly signed by the authorized signatory of the firms. This will be enclosed in **Envelope- II**.
11. The items shall be covered under defect liability for a period of one year from the date of completion.



12. Conditional offers will not be accepted. The offer shall remain valid for 30 days. The rates shall remain firm for a period of one year from date of award. The work order may be extended to cover additional areas at same rates as per institute requirements. No variation in rates shall be applicable.
13. Contractor should depute a qualified supervisor dedicated for this work, who will monitor and coordinate work from contractor's side and interact with the IIITD Engineers, responsible for supervision of work, on regular basis.
14. Rates to quoted are inclusive of all taxes, duties, cartage, loading unloading and shifting to location as called for
15. Contractor will take due permission for entry of all his workers in IIITD. No unauthorized person will be allowed to work inside.
16. During execution of service, Engineer may make minor changes in the scope of work as per site conditions or other reasons. Contractor will have no extra claim in his rates for the same.
17. IIIT-D reserves the right to accept or reject any tender in part or whole without assigning any reasons thereof.
18. Works will be subject to weather conditions and force majeure and depending on availability of site as per IIIT requirements.
