#### MINIMUM QUALIFICATIONS REQUIRED FOR BIDDING

The bidders having following minimum qualification are eligible for bidding:

- 1. Submission of EMD & Tender Fee or valid NSIC / MSME certificate/document.
- 2. The bidder must have minimum 3 (Three) years of experience in providing/hosting DJ and Production services at official gatherings/ events in Central Educational Institutions/ Autonomous Bodies/ Public Sector Undertakings/Central/State Government Departments/Central Research Organizations (Copies of relevant orders and satisfactory user certificates to be submitted as proof along with technical bid).
- 3. The bidder must have executed at least 1(One) contract with satisfactory reports from the users for providing/hosting DJ and production services at official gatherings/ farewell events in Central Educational Institutions/ Autonomous Bodies/Public Sector Undertakings/ MNC/ Corporate Sector/reputed private organization during/Central/State Government Departments/Central Research Organizations of not less than Rs 2 Lac during last seven years. - **4.** The bidder/Company/Firm/Agency must have an average annual turnover of Rs.2.5 Lakhs or more for the last three (3) financial years during the last three (3) financial years. - **6.** Any individual/ Firm which has been blacklisted by IIITD or any other Central/ State Government Organization/ PSU/Universities in the past three financial years, will not be eligible to participate in the tender process. **Annexure-YY**
- 7. The registered office/branch office of the bidder should be located in Delhi/NCR.
- 8. The bidder /Company / Firm / Agency should have its own Bank Account.

Exemption to comply with any of the above criteria must be duly supported by the Government orders and/or OMs and other Government documents and copy(s) of the same must be submitted.
