Contractor must visit site before quoting and fully satisfy himself of the site conditions, restrictions and nature of work. Compensation on account of any site difficulties will be entertained, at a later date, after award of the work.
- 2. Contractors workers must be covid vaccinated and maintain Covid Appropriate Behaviour.
- 3. Any damage done to the equipment/building during execution of work shall be on the part of contractor.
- 4. No T&P shall be issued to the contractor.
- 5. Time allowed : 30 days.
