The tenders will be received at the office of "The Registrar, IIIT-DELHI Okhla Industrial Estate, Phase III New Delhi 110020, shall be deposited in the Tender Box placed at Second Floor, Old Academic Block IIITD, New Delhi, on or before 16<sup>th</sup> July 2021 at 1500 Hrs.

Bids are invited in Two Bids System i.e. (1) Technical and (2) Financial

Technical and Financial bids should be sealed separately and enclosed in a sealed envelope clearly indicating separately Technical Bid for "Supply, Installation, testing and commissioning of various spare parts/ consumable for D- Check (Preventive Maintenance) 1x 500 KVA at IIITD Campus, New Delhi." addressed to Registrar IIIT-Delhi, Okhla Industrial Area Phase-III, New Delhi-110020. Sealed quotations shall be received not later than 3.00 P.M. on 16<sup>th</sup> July 2021. No bids will be accepted after this date & time under any circumstances. The Institute will not be responsible for any postal/courier delay and also for reasons beyond control of the Institute.

- 1. Tenderers are advised to inspect and examine the site and its surroundings etc. and satisfy themselves before submitting their tender as to the nature of works, and the means of access to the site, the accommodation they may require and in general shall themselves obtain all the necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. Tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all the material, tools & plants, water, electricity, access facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract document. Submission of tender by the tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and local conditions and other factors having a bearing on the execution of the work.
- 2. The rates quoted in the tender will not be altered by the contractor during the term of contract.
- 3. Conditional tenders are liable to be rejected. The tenders shall also be rejected if not properly sealed.
- 4. The tender for the works shall remain open for acceptance for a period of 90 days from the date of opening of tenders. If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of the tender which are not acceptable to the Institute, then the Institute shall without prejudice to any other right or remedy be at liberty to forfeit the EMD.
- 5. The competent authority reserves to himself the right of accepting the whole or any part of the tender or distributing the work between one or more tenderers and the tenderer shall be bound to perform the same at the rate quoted.
- 6. The items shall be covered under defect liability for a period of one year from the date of supply and installation.
- 7. Security Deposit @5% of the gross amount of the bill shall be recovered from the bills of the contractor till the sum along with the sum already deposited as earnest money will amount to security deposit of 5% of the tendered amount of the work or cost of actual work executed whichever is more. Bank Guarantee may also be accepted against security deposit to be deducted from the running bills.
- 8. Contractor should depute a qualified supervisor dedicated for this work, who will monitor and coordinate work from contractor's side and interact with the IIITD Engineers, responsible for supervision of work, on regular basis.
- 9. Rates to quoted are inclusive of all taxes, duties, cartage, loading unloading and shifting to location as called for
- 10. Contractor will take due permission for entry of all his workers in IIITD. No unauthorized person will be allowed to work inside.
